| Parameters | Before TCS iON GSP Solution | After TCS iON GSP Solution |

| Login | Taxpayer needs to login to GST Portal and for different GSTIN, there would be different usernames and passwords to be remembered | Single user for different GSTIN so there is no need to login through different GSTIN |
| Upload File | User needs to upload the file in JSON format for filing any return | User can upload file either in excel or csv format and no need to convert the file into JSON format. TCS iON GSP Solution covers the file in JSON, while exchanging data to the Government Portal |
| Multi GSTIN File Upload | User needs to upload the JSON file for different GSTIN after long wait times through different GSTIN | Single file for different GSTIN can be uploaded and it would be processed per GSTIN by TCS iON GSP Solution |
| Multi GSTIN File Download | User needs to login to Portal through different GSTIN and download a particular file separately for each GSTIN | User can login through single login and download files for all GSTIN in one click |
